## **SERVICE AGREEMENT FOR POTABLE WATER SUPPLY**

### **BETWEEN:**

[**RISHIKESH WATER SUPPLIER**], HAVING ITS REGISTERED OFFICE AT [SARI COMPUND] (HEREINAFTER REFERRED TO AS "SERVICE PROVIDER"),

AND

[**NAV DURGA APARTMENT**], LOCATED AT [NEAR NAV JEEVAN VIDYA MANDIR 90FIT ROAD NALLASOPARA ( EAST)] (HEREINAFTER REFERRED TO AS "CLIENT").

### **1. SCOPE OF SERVICE:**

THE SERVICE PROVIDER AGREES TO PROVIDE POTABLE WATER THROUGH WATER TANKERS TO THE CLIENT. EACH TANKER WILL SUPPLY WATER AS PER THE AGREED CAPACITY AND WILL BE DELIVERED TO THE CLIENT'S PREMISES AS PER THEIR REQUEST.


### **2. RATE & PAYMENT TERMS:**

THE RATE FOR EACH TANKER IS ₹1200 (RUPEES TWELVE HUNDRED ONLY) AS OF THE DATE OF THIS AGREEMENT.

THE RATE MAY INCREASE TO ₹1500 (RUPEES FIFTEEN HUNDRED ONLY) PER TANKER DURING THE SUMMER SEASON, DEPENDING ON MARKET CONDITIONS.

PAYMENTS FOR THE SERVICES WILL BE MADE ON A HALF-MONTHLY BASIS (EVERY 15 DAYS).

A SECURITY DEPOSIT OF ₹5000 (RUPEES FIVE THOUSAND ONLY) WAS RECEIVED ON 29TH SEPTEMBER 2024. THIS DEPOSIT IS REFUNDABLE UPON THE COMPLETION OR TERMINATION OF THIS AGREEMENT, PROVIDED THERE ARE NO OUTSTANDING DUES OR DAMAGES.

### **3. SERVICE SCHEDULE:**

THE WATER TANKERS WILL BE DELIVERED BASED ON THE CLIENT'S REQUIREMENTS. THE CLIENT WILL NOTIFY THE SERVICE PROVIDER IN ADVANCE FOR EACH DELIVERY.

### **4. TERM OF AGREEMENT:**

THIS AGREEMENT SHALL REMAIN IN EFFECT UNTIL TERMINATED BY EITHER PARTY, WITH A NOTICE PERIOD OF 30 DAYS.

### **5. RESPONSIBILITIES OF THE SERVICE PROVIDER:**


- ENSURE TIMELY DELIVERY OF POTABLE WATER AS PER THE AGREED SCHEDULE.
- PROVIDE WATER THAT MEETS ALL SAFETY AND QUALITY STANDARDS.

### **6. RESPONSIBILITIES OF THE CLIENT:**

- ENSURE TIMELY PAYMENT FOR SERVICES PROVIDED.
- PROVIDE APPROPRIATE ACCESS AND INFRASTRUCTURE TO FACILITATE SMOOTH DELIVERY OF WATER TANKERS.

### **7. TERMINATION:**

EITHER PARTY MAY TERMINATE THIS AGREEMENT WITH A PRIOR WRITTEN NOTICE OF 30 DAYS. IN CASE OF TERMINATION, ANY PENDING PAYMENTS OR DUES MUST BE CLEARED BEFORE THE SECURITY DEPOSIT IS REFUNDED.
